- Committee members mentioned having our guest speakers at Coffee with Peter getting more speaking time at the beginning of the Coffees.
- Many additions were made under each category of the SWOT analysis and the committee members brought up great points in each category.

Updates

Mr. Kristian reported the following:

- Dolphin Head contract has been signed. The playground is coming down soon. The POA is waiting on the demo permit for the building.
- The Charles and Waterway Gardens are moving forward.
- The Bayshore Cottages are moving along.
- Kids Kamp is in session. We have added six more counselors this week. This is our largest kamp ever.
- The pool is open. The splash pad is having issues and we are working with the pool company to fix them.
- Paving begins next week.
