### New Business

- Ms. Davis reported that our printer for Plantation Living let us know that the price of paper is increasing, therefore our bill for Plantation Living printing has been increased.
- Ms. Davis is meeting with other printers to obtain printing quotes.
- We are no longer working with a graphic designer to finalize the newsletter. All final edits are now completed in house.
- The New Homeowner Meeting is scheduled for Tuesday, October 11 at the Plantation House at 7:00 pm. Our meeting sponsor is Dermatologist, Dr. Cassandra Beard. She is providing refreshments and raffle items. We received a lot of generous donations to raffle off at the event from local businesses.

- Ms. Davis worked with the Security Department to make updates to the POA website. The biggest updated included a fillable PDF to make applying for jobs easier for our Security Department.
- The Volunteer Party is Friday, December 2. All committee members are invited.
- Board Interest Forms are due back to the POA Office no later than Wednesday, November 16.
