- Ms. Davis passed out the 50<sup>th</sup> Anniversary pens to all committee members. Pens are available at the POA Service Center and various community meetings. Ms. Davis is working on a montage style video to display at the November Coffee and opening of the Dolphin Head Facility.

## **Updates**

Mr. Kristian reported the following:

- David Pollock announced his resignation from the POA Board of Directors as his family
  has decided to move away to be closer to family. Mike Harris had the next highest votes
  in the most recent Board Election so he was elected to fill Mr. Pollock's spot. Mr. Harris
  will chair the Maintenance Committee.
- Our August Coffee with Peter was very well attended. Senator Davis was our special guest. Our next Coffee is on September 28 and our special guests will be the Mayor Alan Perry and Town Manager Marc Orlando. The November Coffee will be held on November 16
- The Board decided to let go of our current lagoon maintenance provider. We have hired a new company.
- The Spring Lake Tennis Pro Shop interior has been painted. We have lined four courts for pickleball as the program continues to grow.
- Dolphin Head Update: The sport court has been lined for basketball and pickleball. They
  are getting ready to pave the entrance way. Sidewalks are in. They will be starting the
  screened in porch soon. The wrong counter tops have been installed and staff is working
  on correcting this. The picnic shelter is completed. We are hoping for the project to be
  finalized by late September and staff will alert the community when we plan to have a
  grand opening event.
- The Recreation Committee is working on guidelines for pickleball at Spring Lake and Dolphin Head.
- The 2024 Budget is in progress.
- So far the Dolphin Head project has brought in about \$43,000 in donation items.
- Kids Kamp is over and was a huge success this season.
- The end of summer party for the summer staff was held at Mangiamos.
- Paving continues around the community. Currently they are working on Barksdale Court and Sams Point Lane.
- The New Homeowner Meeting is set for September 11<sup>th</sup> at 7:00 PM.
- Our Group Trip to Italy is sold out with two full buses and a waiting list.
- The School Board Superintendent, Dr. Rodriguez will be coming for a special community meeting on October 11 at 10:00 AM to talk about the upcoming school board referendum.
